Mr. Ignizio opened the meeting with item #1 of the meeting agenda, Hearings on Designating Petitions/Certificates for the August 23, 2022 Primary Election.

Hemalee Patel, General Counsel, was acknowledged, and requested that the Commissioners Committee convene a meeting of the Board of Canvassers.

Secretary Shamoun made a motion to convene a meeting of the Board of Canvassers. Commissioner Umane seconded the motion, which was adopted unanimously.

President Pepe-Souvenir called the meeting of the Board of Canvassers in the City of New York to order to hear challenges to Designating Petitions and Certificates for Public Offices to be contested in the August 23, 2022 Primary Election, for all Boroughs except Staten Island.

Following the meeting of the Board of Canvassers, the regular stated meeting of the Commissioners Committee resumed.

Mr. Ignizio continued with item #2 of the meeting agenda, and requested that the Commissioners Committee make a motion to adopt the minutes of the June 14, 2022 Commissioner Meeting.

President Pepe-Souvenir moved to adopt the minutes of the June 14, 2022 Commissioners Meeting. Commissioner Taylor seconded the motion, which was adopted unanimously.

Mr. Ignizio presented item #3 of the meeting agenda, and provided an update on the June 28, 2022 Primary Election:

- Today is Day 7 of 9, of Early Voting for the June 28, 2022 Primary Election.

- As of 9:30 A.M. this morning, a total of 52,000 voters have voted early.

Mr. Ignizio presented item #4 of the meeting agenda, and asked that the Commissioners designate members of the Commissioners Committee for Petition and Cover Sheet Review, to hear Independent Nominating Petition matters for the November 8, 2022 General Election.
