OPPORTUNITY TO BALLOT (OTB) PETITIONS

First day to circulate OTB Petitions.....Tuesday, March 21, 2023
Last day to file OTB Petitions.....Thursday, April 13, 2023
Last day to file Certificate of Acceptance.....(4) days after last day to file petitions
Last day to file OTB petition if a designated candidate declines.....Thursday, April 20, 2023
Last day to file General Objections.....(3) days after petition is filed
Last day to file Specifications.....(6) days after General Objection is filed

Last day to institute Judicial Proceedings.....(14) Days after last day to file petitions **OR** (3) business days after BOE hearing where designating petition/candidacy is invalidated.
